

PERSONAL DATA PROTECTION LAW (KVKK) APPLICATION FORM

GENERAL EXPLANATIONS

- 1. Under the Personal Data Protection Law No. 6698 (the "Law"), data subjects, as defined in the Law, are granted the right to submit certain requests to data controllers regarding the processing of their personal data, as outlined in Article 11 of the Law.
- 2. In accordance with the first paragraph of Article 13 of the Law, requests related to these rights must be submitted in writing to the data controller, Invent Yazılım Danışmanlık A.Ş. ("INVENT")
- 3. Applications to be made to INVENT "in writing" within this scope shall be made by printing out this form;
 - By delivering the wet signed copy personally or by mailing it to the address "Reşitpaşa Mahallesi Katar Caddesi No:4/1/302 Sarıyer/İstanbul" through a notary public,
 - It can be signed with the "secure electronic signature" of the Applicant defined in the Electronic Signature Law No. 5070 and sent to invent@hs03.kep.tr or info@invent.ai
- If the Personal Data Protection Authority determines and announces additional application methods, notifications regarding such methods will be made available on INVENT's official website.
- 5. Applications submitted to INVENT will be responded to within 30 (thirty) days from the date your request is received by INVENT, in accordance with Article 13(2) of the Law. The responses provided by INVENT will be delivered to you in writing or electronically, as stipulated under Article 13 of the Law.
- 6. If your application incurs additional costs, you will be required to pay the fee determined by the Communiqué on the Principles and Procedures for Applications to Data Controllers issued by the Personal Data Protection Authority. No fee will be charged for written responses up to the first 10 (ten) pages, while a processing fee of 1 TL will be charged for each page beyond 10 (ten) pages. If the response to your application is provided in a recording medium such as a CD or flash drive, the cost of the recording medium will be charged to you.
- 7. INVENT reserves the right to make changes to the application procedures in accordance with decisions by the Personal Data Protection Authority or any future legal regulations.
